The Chief Engineer/ARR, PSPCL has submitted the affidavit explaining his absence on 30.09.2019 in compliance of the directions of the Commission.

After hearing the representative of PSPCL the petition is admitted. PSPCL shall publish a public notice inviting objections from the public on the petition. A copy of the Public Notice as approved by the Commission is enclosed herewith (Annexure-A). The public notice may be got published in five widely circulated daily newspapers (English, Hindi and Punjabi). The notice may be got translated into Hindi and Punjabi by PSPCL for publication in Hindi and Punjab dailies respectively. Before publication of the public notice, the figures mentioned in the public notice may be reconciled with the figures submitted in the petition. The publication of the public notice calling for objections from general public may be arranged immediately but not later than 3 days. The replies to the objections may be prepared and sent to the Commission in ten copies within seven days of receipt of each objection with copy to the objectors.

The Commission vide Order dated 03.10.2019 and 04.10.2019 directed PSPCL to furnish all the relevant information in the matter by 07.10.2019 however, it is noted by the Commission that some of the information is yet to be filed by PSPCL. The same be filed without any delay failing which the said information may not be considered by the Commission for the adjudication of the matter.

The Commission will hold meetings with the officials of PSPCL to discuss the issues involved in the petition. The dates in this regard will be intimated separately. The concerned Director of PSPCL alongwith officers well conversant with the facts of the matter should remain available in the meetings to be held by the Commission.

The hearing as well as public hearing in the petition will be held on 06.11.2019 at 11.00 AM.
