**ORDER**

The Commission observes that PSTCL's petition is still deficient as PSTCL's reply submitted vide letter dated 25.09.2019 to most of the deficiencies pointed out vide the Commission's letter dated 11.09.2019 is that the reply/response will be submitted subsequently.

During the hearing, PSTCL informed that it has submitted the formats through e-mail today itself. In response to the Commission's query regarding the substantial increase in Capital Investment Plan of MYT 2<sup>nd</sup> Control Period over that of 1<sup>st</sup> Control period, PSTCL also informed that it has proposed multiple alternate choices to some of the schemes in the Capital Investment Plan.

The Commission perused the email referred by the PSTCL during the hearing and observed that it contains only formats T-14 and T-15. Thus the Commission directs PSTCL to submit the following within 7 days:

1. Other pending formats annexed with MYT Regulations and reply to other pending deficiencies conveyed vide the Commission's letter dated 11.09.2019.
2. Revised list of schemes under separate headings i.e. Spilled Over Schemes, Emergent Schemes and other Schemes in order of priority. Further, alternate schemes to be clubbed under one scheme containing cost estimate of the scheme with financial justification.

The petition shall be taken up for hearing on admission on 10.10.2019 at 11.00 AM.
