ORDER

The petition was taken up for hearing. It has been submitted that in compliance of the Order dated 07.08.2019 passed by Hon'ble Supreme Court, PSPCL has paid an amount of Rs. 421,77,01,158/and Rs. 1002,05,32,597/- to NPL and TSPL respectively. The said amount paid by PSPCL becomes a part of the revenue requirement of PSPCL to be recovered in the retail supply tariff from the consumers by increase in the tariff at the earliest to avoid adverse effect on the finances of PSPCL and its operations. The relief claimed by PSPCL affects the interest of the consumers at large. PSPCL shall publish a public notice inviting objections/suggestions from the public as required under Regulation 67 of the PSERC (Conduct of Business) Regulation, 2005, without any delay.

PSPCL shall submit its proposal(s) giving the plans to recover the amount from the consumers. PSPCL shall also file an affidavit giving the month wise details of payment with a breakup of the expenses for washed/un-washed coal & on GCV/Transportation. PSPCL shall submit the above information by 06.11.2019.

The counsel for PSPCL has submitted that a miscellaneous application has been filed before the Hon'ble Supreme Court for clarification of the amount which is disputed by NPL and TSPL. PSPCL is directed to submit 7 copies of the miscellaneous application.

The petition shall be taken up for hearing as well as public hearing on 04.12.2019 at 11.00 A.M.
