information, with a copy to PSPCL (through hard copy & soft copy) latest by 10.05.2019 and PSPCL may reply to the said point wise information by 20.05.2019.

Despite the direction by the Commission, vide order dated 07.02.2019, to GVK to submit the capital cost of the project up to the date of COD as certified by the auditors appointed jointly by GVK and PSPCL within a month, the requisite information has not been submitted so far. The same be filed latest by 29.05.2019.

The petition shall be taken up for hearing on 29.05.2019 at 11.00 AM.
