PSPCL has not submitted the information as required by the Commission i.e., break up of monthly average cost of own coal provided by PSPCL. PSPCL has filed information regarding weighted average cost of coal

of each plant but not for each month from them. PSPCL has also not submitted weighted average cost of coal of its Thermal Plants and has given only component wise final figures. PSPCL is directed to provide the information by tomorrow with a copy to GVK (through hard copy & soft copy). GVK shall file reply to the information filed by PSPCL within a week.
