- 2. In Annexure H- PSPCL has shown 'Total Other Charges' of NPL as Rs. 14.7315234 including Rs. 0.0392308 Crore Supplementary Variable charges. PSPCL has not reduced the same from other charges. PSPCL to review and resubmit the same
- 3. In Annexure H, PSPCL has shown Rs. 17.03 Crore on account of PSTCL (SLDC Charges). PSCPL has already included Rs. 1683.69 Crore Intra-State Transmission Charges in Total Fixed Costs of Distribution Licensee shown in Annexure-J resulting in double accounting of the same. PSPCL to review and resubmit the same.
- 4. PSPCL to submit the break-up of Rs. 235.99 Crore Open Access Charges submitted in Annexure-H.

5. Minor Variation in OA Data-(MUs) during the month submitted in Annexure B of the petition and the data regarding open access received by PSTCL vide email on monthly basis. PSPCL to review and resubmit the same.
