ORDER

The petition was taken up for hearing. Chief Engineer (CE)/Metering, PSPCL representing PSPCL submitted that the tender enquiry in progress for procurement of power quality meters was dropped and a fresh tender enquiry for the same would be issued on 19.02.2025. CE/Metering is directed to confirm the issuance of the tender enquiry along with complete timelines of the procurement and installation of Power Quality meters. The Commission pointed out that PSPCL has now submitted an affidavit that 652 nos. applications for rental options were received before 15.03.2024, whereas the same was intimated as 177 nos. vide Para 3(B) of the petition and also vide PSPCL earlier email/memo dated 14.06.2024 and 11.09.2024. PSPCL has now attributed this discrepancy to the procedural lapses. The reasons of furnishing contradictory information to the Commission be intimated by PSPCL. However, the procedure was well-defined by PSPCL vide Sr.No.5 of their Commercial Circular no. 01/2024 dated 05.02.2024. Thus, the action taken PSPCL against the delinquent officers/officials for aforementioned procedural lapses may be intimated. In view submission by CE/Metering during the hearing that the matter related to the CE/Commercial, the Commission directs PSPCL to ensure the physical presence of CE/Metering and CE/Commercial in the next hearing.

Further, vide Regulation 13.4 of the Power Quality Regulations, the applicants covered under the category of designated consumer seeking new connections/extension in load shall install PQ meters before release of new connection/extension of load. PSPCL has now intimated on affidavit that new connection/extension of load in 177 nos. such cases was done without PQ meters due to non-availability PQ meters in metering labs. However, the Power Quality meters in such cases were to be procured and get installed by the consumer. Such irresponsible/irrelevant reply of PSPCL is not acceptable. Accordingly, PSPCL is directed to explain the reason for non-installation of Power Quality meters in such cases and the action taken against the delinquent officers/officials for violation of the Regulations.

Further, as per the first proviso to Regulation 13.8 ibid, PSPCL was also directed that the accounts of the designated consumer who had already

opted for General Category tariff, be overhauled retrospectively by making the refund along with the interest @ MCLR for one year of the SBI as applicable on the first April of the financial year for which interest is payable. However, vide their memo no. 5169 dated 31.01.2025, PSPCL has not intimated any details in this regard except intimating that the instructions have been given to the offices for compliance of the directions of PSERC. The reasons for intimating the above details along with the latest status of overhauling the accounts of such consumers be intimated alongwith the latest number of designated consumers who have opted for general category tariff.

PSPCL is directed to submit a comprehensive response to the aforementioned directions on affidavit well before the next date of hearing.

The petition shall be taken up for hearing on 28.02.2025 at 11:30 A.M.
