Petition under regulation 68, 69, 70, 71 and 72 and other relevant provisions of Chapter XIII of the Conduct of Business Regulations 2005 as amended up to date and Section 62 read with Section 86 (1) (e) and other relevant provisions of the Electricity Act, 2003 for declaring the financial year 2019-20 as the year of commissioning for the Mini Hydel Project commissioned by the petitioner and granting the tariff for the project for sale of electricity to the Respondents in terms thereof and the bidding process carried out by Respondent No. 2, where under a discount of Rs. 1.51/- was offered by the petitioner, thus arriving at a net tariff Rs. 4.72 (Rs. 6.23 – Rs. 1.51 = 4.72) AND for passing any other relief in favour of the petitioner as this Commission may deem fit in the facts and circumstances of the case.
