For inviting objections in respect of Petition No.25 of 2019 filed by Punjab State Power Corporation Limited under section 86 (1) (a) read with Section 62 of the Electricity Act, 2003 in regard to the inclusion of the amount payable by the Petitioner to Nabha Power Limited (NPL) and Talwandi Sabo Power Limited (TSPL) under their respective Power Purchase Agreements as interpreted and implemented by the decision of the Hon'ble Supreme Court dated 07.08.2019 and appropriate direction for tariff to be recovered from the consumers.

Notice is hereby given to all that the Punjab State Power Corporation Limited (PSPCL) has filed subject cited Petition No. 25 of 2019 for recovery of amount paid to NPL and TSPL in compliance to Hon'ble Supreme Court order dated 07.08.2019 in contempt petitions Nos. 1766-67 of 2018 and 1277-78 of 2018 filed by TSPL and NPL respectively.

If the objection is filed on behalf of any organization or any class of consumers, it should be so mentioned.
