

PUBLIC NOTICE

FOR INVITING OBJECTIONS/COMMENTS FROM THE GENERAL PUBLIC/STAKEHOLDERS ON PETITION NO. 50 OF 2015 FILED BY NAHAR INDUSTRIAL ENTERPRISES LIMITED FOR AMENDMENT IN REGULATION 31 (1) (C) AND ON PROPOSAL OF THE STAFF OF THE COMMISSION FOR AMENDMENT IN REGULATION 42 OF PSERC (TERMS AND CONDITIONS FOR INTRA-STATE OPEN ACCESS) REGULATIONS, 2011.

1. Nahar Industrial Enterprises Limited has filed Petition (50 of 2015) with the Commission in which one of the issues raised is regarding banking of the power as per Regulation 31 (1) (c) of PSERC (Terms and Conditions for Intra-State Open Access) Regulations, 2011 (Open Access Regulations). The Petitioner has prayed in the Petition to adjust the power of captive co-generation NRSE based plant, banked under open access, due to non-availability of the Transmission/Distribution System, in the monthly bills of the Drawing Unit or be allowed to be drawn within one year of the date of banking, against 15 days as provided in Regulation 31(1) (c) of the Open Access Regulations.
2. Further, it is proposed to amend Regulation 42 of the Open Access Regulations, in order to ensure full RPO compliance by the Open Access Customer(s), by adding new clause 2 in Regulation 42 of the Open Access Regulations, as brought out in the Discussion Paper.
3. Objections/comments on Petition No. 50 of 2015 filed by Nahar Industrial Enterprises Limited for amendment in Regulation 31 (1) (c) and on proposed amendment in Regulation 42 of the Open Access Regulations, as discussed in the Discussion Paper, together with supporting material, may be filed with the Secretary, Punjab State Electricity Regulatory Commission, SCO 220-221, Sector-34A, Chandigarh, in person or through Registered Post, so as to reach him by 15.01.2016. Copy of the same must also be sent to the Chief Engineer/ARR & TR, PSPCL, F-4, Shakti Vihar, Patiala and Financial Advisor, Punjab State Transmission Corporation Limited, opposite Kali Devi Mandir, Patiala and proof of the same must be enclosed with the filing made to Secretary, Punjab State Electricity Regulatory Commission, Chandigarh.

4. Discussion Paper with regard to above matters has been prepared by the staff of the Commission and is available on the website of the Commission www.pserc.nic.in. The Discussion Paper does not necessarily represent the views of the Commission.
5. The objections/comments to the Commission should be filed in ten copies and carry full name and postal address of the person sending the objections/comments. If the objections/comments are filed on behalf of any organization or any class of consumers, it should be so mentioned. It may also be specifically mentioned if the objector also wants to be heard in person.
