ORDER:

Petition No. 70 of 2022 and Review Petition No. 01 of 2023 in Petition No. 38 of 2022 were clubbed with Petition No. 62 of 2021 vide order dated 18.01.2023 and 13.04.2023 passed by the Commission in Petition No. 70 of 2022 and Review Petition No. 01 of 2023 respectively. The Petition was taken up for hearing. The Commission observes that technical study of the processes of industries under reference submitted by PSPCL is theoretical in nature & not supported by any power quality harmonic data of industrial consumers under reference. PSPCL was asked vide interim Order dated 19.07.2023 to furnish the requisite Power Quality harmonic data which is yet to be furnished. During the hearing, PSPCL submitted that it has selected 43 No. industries for installation of PQ meters to fetch the requisite data and has already installed 13 no. PQ meters. PSPCL further submitted that the consolidated data

shall be submitted to Commission after installation of the balance meters. PSPCL is directed to submit the Power Quality harmonic data of the industries under reference within three weeks (through hard & soft copy). Also, the Commission observes that PSPCL has shortlisted two No. vendors for supply & sale of PQ meters. PSPCL is directed to expeditiously empanel more vendors for supply of power quality meters.

In the meanwhile, PSPCL is also directed not to charge PIU tariff from the industries which are not included in the list of declared PIU industries and have been referred to the Commission in this petition till the petitions are disposed of with appropriate orders.

The Petition shall be taken up for hearing on 11.10.2023 at 11.30 AM.
