**ORDER**

The Review Petition was taken up for hearing on admission. After hearing the Ld. Counsel for PSPCL, Review Petition is admitted. PSPCL shall publish a public notice inviting suggestions/objections from the public/stakeholders as required under Regulation 67 of the PSERC (Conduct of Business) Regulations 2005. The Review Petition shall also be uploaded on the website of PSPCL as well as website of the Commission. PSPCL shall further provide the information as under:

- Details of power purchase cost of Rs. 30.12 Crore (Rs. 1.20 Crore payment to BBMB SLDC charges and Rs. 28.92 Crore liquidated damages paid to NPL) being sought in Para No. 5.10 of the Review Petition and to provide the PPA details under which payment has been made to NPL.  
PSPCL also needs to clarify how the referred BBMB SLDC charges are part of its power purchase as PSPCL has not claimed any BBMB SLDC charges in Power purchase ever before.
- The OEM documents specifying Static Exciters based on which the higher auxiliary consumption is being claimed in Para No. 23 of the Review Petition.

- Year wise details of loans as per following format in order to examine the claim as sought in Review Petition No. 04 in Petition No. 74 of 2023.
