ORDER

The Review Petition was taken up for hearing on admission. The Ld. Counsel for the Petitioner has submitted that as per the provisions of Section 61 (g) and Section 62 of the Electricity Act 2003, the determination of cost of supply should be based upon the voltage rather than an aggregate but while determining the Tariff for FY 2023-24, the objection/representation filed by the Petitioner against the public notice dated 27.12.2022 seeking assessment of cost of supply on the basis of voltage i.e. 400 KV has not been considered and appreciated by the Commission. After hearing the Ld. Counsel for the Petitioner, Review Petition is admitted. Petitioner shall publish a public notice inviting suggestions/objections from the public/stakeholders as required under Regulation 67 of the PSERC (Conduct of Business) Regulations 2005. The Review Petition shall also be uploaded on the website of the Commission.

Notice be issued to PSPCL. PSPCL shall file its reply to the Review Petition within two weeks with a copy to the Petitioner (through hard copy & soft copy) and the petitioner may file rejoinder thereto, if any, within one week thereafter with a copy to PSPCL.

The Review Petition shall be taken up for hearing as well as public hearing on 25.10.2023 at 11.30 AM.
