1. Details annexed at –Annexure ‘B’ regarding AP subsidy in Review Petition No. 06 of 2019, do not appear to have been provided in Petition No. 02 of 2019. Hence, please explain the same and also state how the same falls within the purview of the present review petition.
2. PSPCL may state the accounting procedure/standard under which interest income earned on delayed subsidy amount and disallowances made in the previous year have been considered as a part of income of Agriculture

Supply (Tariff Compensation from State Government) in subsequent years.

3. Documents of loan sanctioned @ 11.29% by Bank for working capital of each Generating Stations and Distribution System, do not appear to have been provided in the original Petition No. 02 of 2019. Hence, please explain how it falls within the purview of the present review petition.
