Punjab State Electricity Regulatory Commission invites applications from interested eligible persons for nomination as an Independent Member to the Forum constituted under Sub –Section (5) of Section 42 of the Electricity Act 2003 for redressal of grievances of the consumers.

2. The nominated Member shall carry out the functions/duties entrusted to the forum as envisaged under Sub –section (5) of Section 42 of the Electricity Act 2003 read with the "PSERC (Forum and Ombudsman) Regulations 2005", as amended from time to time.

3. In order to be eligible for consideration of nominations as Member to the Forum, the applicant should be atleast 45 years of age and a Post-graduate. Preference will be given to the person who has association of an NGO, knowledge of Power Sector and familiarity with consumer affairs and arbitration matters.

4. The candidate should not have been in employment in any capacity under/or in any agency of Distribution Licensee.

5. Initially, the nomination shall be for a period of two years. The nominated Member will hold office for a maximum period of three years subject to overall age limit of 65 years.

6. Member will be paid a consolidated amount of Rs.30,000/- (Rupees thirty thousand only) Per Month towards remuneration. In addition, he will be entitled to all office facilities and TA/DA as admissible to Group-A Officers of the State Government.

7. His headquarter shall be at Patiala or at the station where the office of the Forum is located.

8. In respect of any matter not specifically mentioned above, the nomination will be governed by the terms and conditions as specified in the "PSERC(Forum and Ombudsman) Regulations 2005" as amended from time to time.
