**ORDER**

The petitioner filed the present petition for grant of grid feasibility clearance to its co-generation Power Project of capacity of 40 MW at Mukerian, District

Hoshiarpur, Punjab. The petition was admitted vide order dated 19.03.2018. The respondents have filed the respective reply to the petition and the petitioner has also filed rejoinder to the replies. The parties were heard on 26.09.2018 wherein the petitioner and PSPCL submitted that they will sort out the issues amicably and accordingly the petition was adjourned. Vide order dated 22.11.2018 the parties were directed to endeavour for amicable settlement of the issue(s) and file the necessary information.

The petition was fixed for hearing on 06.02.2019 and during hearing PSPCL submitted that on the basis of issues mutually agreed by both the parties, Supplementary PPA has been signed on 05.02.2019 with the petitioner. PSPCL also submitted a copy of the supplementary PPA dated 05.02.2019. The parties have submitted that as the issues have been amicably settled between the parties vide supplementary PPA dated 05.02.2019, therefore nothing survives in the petition. However, the petitioner/PSPCL shall apply for seeking approval of the PPA by the Commission in terms of section 86 (1) (b) of the Electricity Act 2003 and the applicable regulations framed there under.

The petition is disposed of in terms of above.
