## PUNJAB STATE ELECTRICITY REGULATORY COMMISSION SCO 220-221, SECTOR 34-A, CHANDIGARH

## Public Notice

- Public Notices were issued by the Punjab State Transmission Corporation Limited 1. (PSTCL) and Punjab State Power Corporation Limited (PSPCL), which appeared in various newspapers on 29/30.12.2015 and 25.12.2015 respectively, for inviting objections/comments on the Annual Revenue Requirement (ARR) and Tariff Petitions filed by PSTCL and PSPCL for FY 2016-17, with the Punjab State Electricity Regulatory Commission (Commission) as Petition No. 78 of 2015 and Petition No. 79 of 2015 respectively. The last date for submitting the comments was 30 days from the date of publication of notices. Thereafter, the Commission held public hearings at various places in the State of Punjab. The date of hearing of comments of PSTCL and PSPCL to the objections raised by the Public, besides Corporations' own point of view regarding the ARR Petitions fixed for 18.03.2016 was cancelled by the Commission in view of entering into a tripartite Memorandum of Understanding (MoU) among State Government, PSPCL and Government of India, regarding Ujwal Discom Assurance Yojana (UDAY) Scheme. The Commission asked PSTCL and PSPCL to submit the revised ARR and Tariff Petitions after incorporating the impact of UDAY Scheme on the various elements of the ARR Petitions filed by PSTCL and PSPCL for FY 2016-17. PSPCL has filed with the Commission, the revised figures of ARR for FY 2016-17, after incorporating the impact of UDAY Scheme. PSTCL has not filed any revised figures. Thereafter, a public notice has been issued by PSPCL, which appeared in various newspapers on 23.04.2016, for inviting objections/comments on the revised figures of ARR for FY 2016-17 filed by PSPCL, after incorporating impact of the UDAY Scheme. The last date for filing the objections/comments on the revised figures is 15 days from the date of publication of public notice.

The Commission will hear the comments of Punjab State Transmission Corporation Limited and Punjab State Power Corporation Limited to the objections raised by the Public, besides Corporations' own points of view regarding the ARR Petitions for FY 2016-17, at Commission's office i.e. SCO 220-221, Sector-34-A, Chandigarh, on 16<sup>th</sup> May, 2016, from 11:00 AM to 01:30 PM (to be continued in the afternoon, if necessary).
- All the objectors who have filed their objections with the Commission by the last date for filing of the objections and other persons/organizations interested in presenting their views/suggestions on the above mentioned matters before the Commission are invited to participate.
