During hearing, the Appellant's Representative presented his case & arguments of both the parties were heard. This Court observed that the Appellant deposited ₹ 22,40,821/- on 30.08.2018 as tentative cost for a 11 KV feeder emanating from proposed new 66KV Substation Ramgarh Bhuda as per NOC



But till date no work has been done in this regard by the PSPCL even when the proposed 66KV Substation Ramgarh Bhuda was erected in year 2020 as informed by the Respondent. The Respondent was directed to give reasons for the same before the next date of hearing.

The Appellant also deposited ₹ 3,09,893/- for release of partial load of 495 kW/300 kVA on 30.08.2018, then deposited ₹ 3,35,335/- on 07.04.2022 for extension in the already availed part load of 495kW/300kVA to 990kW/700kVA & further deposited ₹ 3,55,405/- on 03.01.2024 for extension in the already availed part load of 990kW/700kVA to 1990kW/1200kVA. The Respondent was directed to provide the copies of IWR of all these amounts/estimates before the next date of hearing.

The Appellant's Representative pleaded that the Respondent has not provided the calculation of ₹ 3,83,421/-given as refund to the Appellant due to the implementation of the decision of the Corporate Forum. The Respondent was directed to provide the same to the Appellant before the next date of hearing with a copy to this Court. The Respondent asked for some time which was granted by this Court.
