**Tender Notice**

1. Sealed Tenders are invited from bidders upto 29.05.2019 (03.00 PM) for the disposal of Surplus store. The Tender will be opened by the Disposal Committee in the presence of Tenderers or their representatives, who may present present on 29.05.2019 at 4:00 PM in the Commission's office.
2. The materials offered for disposal is on "AS IS WHERE IS & WHAT IS BASIS"
3. The purchaser may inspect the materials on any working day to satisfy themselves about the quality & condition of the materials offered. No complaint whatsoever will be entertained after the tenders are submitted or before or after the materials are lifted. No request for samples or inspection after submission of the tender will be accepted.
4. Tenders should clearly quote their composite rates, both in figures and in words. Any overwriting in rates or any change is liable to culminate in the outright rejection of the tender. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.
5. Tenders will be valid for a period of 30 (thirty) days from the date of opening of the tenders.
6. Earnest Money deposit equivalent to 10% of the reserve price is to accompany the bids in the shape of Demand Draft in favor of Secretary, Punjab State Electricity Regulatory Commission, Chandigarh in a separate Envelope. Tenders not accompanied by EMD will be rejected. No interest will accrue on the EMD so deposited.
7. The Sold material is to be lifted within 3 days from the date of issue of award letter. In case it is not lifted within the time specified ground rent as decided by the committee per lot per day will be charged from the purchaser for a further period of 7 days. The materials not so removed will be treated as abandoned lots and the EMD and other sums paid for the lot will be forfeited without any reference to the purchaser. For such abandoned lots, PSERC reserves the right to re-sell.
8. Mis-description or error in quantity will not invalidate a sale.
9. The labour, transport and other arrangements will have to be made by the purchaser at their risk, cost and responsibility.
10. The Purchaser or person authorized by the purchaser will be allowed to take delivery.
11. PSERC reserves the right of withdrawing from the sale of any material at any stage without assigning any reasons thereof.
12. The address given in the tender shall be deemed to be the Purchaser's address and correspondence sent on that address shall be considered to have been delivered to the purchaser. No claim will be entertained for the reason of



forfeiture of the sum deposited in case the correspondence is returned back undelivered.

13. The Commission has the right to accept or reject any bid without assigning any reason.
14. Bids once submitted cannot be resubmitted, withdrawn or changed.
15. The tenderer shall bear all costs associated with the preparation and submission of his tender and the Commission shall in no case be liable for the same.
16. Each tenderer shall submit only one tender, either by himself or as a partner in a joint venture. A tenderer who submits or participates in more than one tender, will be disqualified.
17. The following documents shall accompany the tender:
  - a. Income tax clearance certificate
  - b. Copy of PAN.
  - c. Partnership deed or Registration certification of the firm or Certificate of incorporation of Company as the case may be.
  - d. Power of Attorney in case of joint venture.
18. Conditional Tender shall not be accepted.
19. The earnest money of the successful bidder will be converted to security deposit towards the work.
20. The Commission does not bind itself to accept the highest rate tender and reserves the right of accepting any tender without assigning any reason.
